

## Privacy Policy

This Privacy Policy describes how *Centre for Astrological Evaluation* (“we”, “us”, “our”) collects, uses, shares, and protects information obtained from users (“you”, “your”) of our website <https://centreforastrologicevaluation.com/> (the “Website”). By accessing or using the Website, you agree to the practices described in this Privacy Policy.

### 1. Information We Collect

We collect the following types of information:

- **Personal Information:** When you fill out contact/query forms, register for services, subscribe to newsletter, etc., we may collect your name, email address, phone number, date of birth, gender, address, and other relevant details.
  - **Usage Information:** Information about how you use the Website — e.g. pages visited, time spent, referring URL, browser type, IP address.
  - **Device & Technical Data:** Device type, operating system, browser, location (approximate, based on IP), and other diagnostic/technical data.
  - **Cookies & Tracking Technologies:** We may use cookies, web beacons, similar tracking technologies to enhance your experience, store preferences, and gather statistics.

### 2. How We Use Your Information

We use the collected data for purposes including:

- To provide, maintain, and improve our services (astrology, palmistry, numerology, etc.).
  - To respond to your inquiries, requests, and provide customer support.
  - To send you updates, newsletters or promotional materials (only if you consent).
  - To detect, prevent and address technical issues and security threats.
  - To comply with legal obligations (e.g. record-keeping for laws/regulators).

### 3. Legal Basis (India)

Under Indian law (including the Information Technology Act), we process your personal data:

- with your consent (e.g. when you provide information);

- as necessary for performance of a contract (if you hire us for services);
  - as required by law (for compliance, dispute resolution, etc.).

#### 4. Sharing & Disclosure

We will not rent, sell or share your personal information with third parties except as described below:

- **Service Providers:** We may share data with third-party vendors who assist us (e.g. hosting, email delivery, analytics) under confidentiality obligations.
  - **Legal Requirements:** If required by law, or to comply with a court order/regulatory requirement.
  - **Business Transfers:** If we are involved in any merger, acquisition, reorganization, or sale of assets, your information may be transferred.

#### 5. Data Retention

We retain your personal information only as long as is necessary for the purposes for which it was collected, or as needed to comply with legal obligations. Once no longer required, we securely delete or anonymize your data.

#### 6. Security

We implement appropriate technical and organisational measures to safeguard your data against unauthorized access, disclosure, alteration or destruction. However, no internet transmission is fully secure, so while we strive to protect your information, we cannot guarantee its absolute security.

#### 7. Cookies / Tracking Tools

- We use cookies and similar technologies to improve user experience, analyze usage, and track preferences.
  - You may browser settings to block cookies or to be notified when a cookie is sent.  
Note: blocking certain cookies may affect functionality of the Website.

#### 8. Your Rights

Depending on applicable law, you may have these rights:

- To access, update, or correct your personal information.
- To withdraw consent where processing is based on consent.
- To request deletion of your personal information.
- To object to certain data processing (e.g. direct marketing).
- To data portability (if applicable).
